FREDERICK SCULLY REAL ESTATE COLLECTION

The Frederick Scully Real Estate Collection was given to the Grosse Pointe Historical Society by Mrs. Frederick Scully in October 2002 and April 2003. Once arranged and a finding aid completed, the collection was opened for public use without restrictions in May 2003.

This collection contains materials which pertain to the development of Grosse Pointe area real estate by both Arthur Scully and his son, Frederick. Arthur J. Scully was born on April 6, 1884 in Dubois, Pennsylvania and died on April 26, 1968 in the Detroit area. He attended the University of Michigan for his undergraduate and graduate work after which he was admitted to the Michigan Bar in 1909 and the New York Bar in 1911. From 1913 to 1917, he was a realtor in San Diego, California. He then returned to Detroit where he served as assistant general manager for the Houseman-Spitzley Co. for one year before opening his own real estate firm. He quickly became known for the successful development of properties on Detroit's East Side including the Nottingham Subdivision. He was married to Luella Granger; the couple had a son, Frederick, and a daughter, Patricia. A Catholic, Mr. Scully belonged to the Knights of Columbus.

Frederick (Fritz) G. Scully was born in Philadelphia, Pennsylvania in 1904 and died July 6, 1989 in Grosse Pointe. He attended Cornell University and obtained a law degree from the Detroit College of Law. After graduation, he became a realtor in Grosse Pointe where he worked for his father's company, developing various subdivisions including Oxford Rd. In 1929, he married Elizabeth Martz; they had three children, Frederick G. Jr., Suzanne and Virginia. After taking over the business upon his father's retirement. Mr. Scully formed Scully-Hendrie Inc. in the 1970s, with his nephew, Michael Hendrie, a builder who had obtained a real estate license In later years, Mr. Scully was a lay minister and usher at Our Lady Star of the Sea Catholic Church in Grosse Pointe Woods.

Much of this collection, though from Scully & Hendrie Inc., was created when the office at 20169 Mack Ave was known as the Arthur J. Scully Co. It contains a variety of documents including correspondence, local government regulations, legal forms, statistics, property lists, promotional materials, data from other realtors, construction information, abstracts and a few photos. The following are larger items, such as plat books, blueprints, maps and certificates, which have been removed and stored in the Atlas bookcase or in File 33:
